

## **Higher Education Emergency Relief Fund Report – Emergency Financial Aid Grants to Students**

**Date** Dec 31,, 2020

**Name of institution** FVI School of Nursing and Technology(OPE ID:04206300 received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”), Public Law No: 116-136. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund that is designated exclusively for emergency financial aid grants to students.

The institution appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic. We take receipt of these federal funds seriously and are distributing them in accordance with the CARES Act and implementing guidance.

1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students is **\$311,582.00**
3. The total amount of emergency financial aid grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is **\$275,029.00**

## Attachment A

### Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act Section 18004(a)(1) of the CARES Act, Pub. L. No. 116-136 (March 27, 2020)

Award Determination Policy and Procedures: Florida Vocational Institute (FVI)

The institution has put in place a CV-19 Grant Management team which has developed policy and procedures for the management of Grant funds obtained under the CARES ACT.

#### Award Methodology:

Absent any standardized Needs Analysis associated with the COVID 19 crisis, and with the understanding that any need determination would be subjective under the current circumstances caused by the COVID-19 disruption of campus based education, the team has determined that the most equitable distribution formula would be to award all students an equal amount of money. The need determination under Title IV prior to the COVID 19 virus period is not the same level of need that students currently experience. This assumption is driven by the following:

- A new study by the [StratoDem Analytics](#) data firm in Cambridge, Mass., suggests [economists' fear was spot-on](#). The coronavirus isn't putting us at risk of a recession. The COVID-19 recession is already here — especially in tourism-centric South Florida. Chung said the coronavirus outbreak simply accelerated the national bursting of asset bubbles such as real estate and commercial debt.
- The massive loss of jobs in southern Florida, because of the large number of persons employed in tourist related businesses such as restaurants, hotels, clubs, cruise ships industry, food service industry, airports, and the numerous small businesses that proliferate both Miami-Dade County and Broward County. Leisure and Hospitality have been affected the worst. FVI has a school located in both counties. The majority of population in southern Florida lies in Miami-Dade and Broward Counties.
- Miami-Dade and Broward counties, with [their heavy reliance on tourism](#), will be hit even harder. According to the study, Miami-Dade is forecast to suffer a -21.5 percent drop in GDP, or a \$9 billion loss. Broward will see a -22.7 percent drop, equaling a \$6.1 billion loss.
- The Miami-Dade figure breaks out into \$8,000 less spending per household in Q2, mostly due to job losses. In Broward, it means \$7,700 per household.

**Florida Projected job loss as a share of total private-sector employment: 17.0%** Projected job loss: 1,330,384 Implied unemployment rate, July 2020: 15.5% Implied unemployment level in July assuming no change in labor force: 1,621,074 **Leisure, hospitality, and retail as a share of total private-sector employment: 30.2%**

Unemployment generates a domino effect in that job losses in one sector roll over to other sectors. Having student provide debt information gives no assurance of accuracy without extensive examination of the reported debt. Thus, the decision to award uniform amounts to each student.

Under the CARES Act, Pub. L. No. 116-136**

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into law. The CARES Act authorized the Higher Education Emergency Relief Fund which provides emergency funding for student and institutions impacted by the COVID-19 pandemic.
